1. Introduction :

Jawaharlal Nehru National Solar Mission (JNNSM) scheme, a Govt. of India initiative, under the brand "Solar India" is set out to establish India as a global leader in solar energy as mission objective. The Mission has set a target of 20,000 MW in 3 phases (1st phase up to 2012-13, 2nd phase from 2013- 2017 and 3rd phase from 2017 – 2022). Total capacity of Solar PV projects to be selected shall be 350MW (approx). However final capacity would be declared at the time of short listing before March 2012.

NVVN has been designated as the Nodal Agency for procuring the solar power by entering into a Power Purchase Agreement with the Project Developers.

Interested Project Developers are hereby invited to participate in the selection process and obtain the RFS documents as mentioned below.
