Subject: Status of Commissioning of 20 Solar PV Projects located in the State of Rajasthan under JNNSM Phase-I, Batch-I

- 1.0 Under JNNSM Phase-I Batch-I, PPAs were signed in the month of January 2011 for 28 Solar PV Projects for total capacity of 140MW with each Project having capacity of 5MW. These Projects were to be commissioned by the Solar Project Developers (SPD) within one year from the date of signing of PPAs and accordingly, Projects were to be commissioned from 7th January 2012 to 9th January 2012. Out of these 28 Projects, 20 Projects are located in the State of Rajasthan and balance is located in the States of Andhra Pradesh, Karnataka, Maharashtra, Orissa, Uttar Pradesh and Tamilnadu.
- 2.0 The Responsibility for ascertaining the commissioning of these Projects was entrusted to State Nodal Agencies in the respective States viz. Rajasthan Renewable Energy Corporation Ltd. (RRECL), Non Conventional Energy Development Corporation of Andhra Pradesh (NEDCAP), Karnataka Renewable Energy Development Agency Ltd. (KREDA), Maharashtra Energy Development Agency (MEDA), Orissa Renewable Energy Development Agency (OREDA), Non conventional Energy Development Agency (NEDA) UP and Tamilnadu Energy Development Agency (TEDA).
- 3.0 Ministry of New and Renewable Energy (MNRE) in the Month of February, 2012 issued elaborations/clarifications on commissioning of the Solar PV Projects and directed all State Nodal Agencies to comply with.

- 4.0 Subsequently, a Committee comprising of representative from RREC, RDPPC, RVPNL, NVVN and SPD was constituted by RREC for ascertaining the commissioning of 20 PV Projects located in State of Rajasthan.

The Committee members collected the information/data of these Projects from State Agencies and SPDs for assessment of date of commissioning of the Projects based on the elaborations issued by MNRE.
- 6.0 The dates of commissioning based on the findings of the Committee for these 20 projects located in the state of Rajasthan are placed at Annexure-I.
